The above Standalone audited financial results for the quarter and year ended March 31, 2021, were reviewed and recommended by the Audit Committee and were taken on record by the Board of Directors at its meeting held on Monday, 28th June, 2021 and the statutory auditors have carried out a Limited Review of the Financial Results for the quarter and year ended March 31, 2021 as required under Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulation, 2015.
2. As the company operates only in one reportable segment i.e. Hospitality/ Hotels Business. Hence no segment wise reporting required under Ind AS- 108 on 'Segment'.
3. The Company adopted Indian Accounting Standards ("IND AS") and accordingly these financial results have been prepared in accordance with the recognition and measurement principles laid down in the Ind AS financial reporting under Section 133 of the Companies Act, 2013.
4. The figures for the previous period have been regrouped, rearranged and reclassified wherever necessary to confirm the current years figures, and as per the Ind AS schedule III to the Companies Act, 2013.
5. Due to the outbreak of Covid-19 globally and India, the company's management has made initial assessment of the likely adverse impact on business and financial risks, and believes that the impact is likely to be short term in nature. The management does not see any medium to long term risk in the company's ability to continue as going concern and meetings its liabilities as and when they fall due.
6. The figures of the last quarter are the balancing figures between audited figures in respect of full financial year up to March 31, 2021/ March 31, 2020 and the unaudited year to date figures up to December 31, 2020/ December 31, 2019 being the date of the date of the third quarter Financial year respectively which were subject to limited review.
